Re: IBEW Support for Micron Semiconductor Plant in Boise, Idaho

Dear Ms. Baldwin:

On behalf of the 820,000 active and retired members of the International Brotherhood of Electrical Workers (IBEW), I write in support of Micron's \$15 billion plan to expand its semiconductor plant in Boise, Idaho. It is my understanding that Micron expects to employ up to 7,000 construction workers for the project, which will be a boon to economic development in the local community while contributing to the nation's resurgent advanced manufacturing industry and bringing home a critical supply chain component of so many durable goods.

The IBEW has played a critical developmental role in semiconductor projects across the country, both before and following the passing of the landmark CHIPS and Science Act. In this regard, the IBEW has signed project labor agreements (PLAs) with Intel, GlobalFoundries, and indeed – Micron – to construct a semiconductor plant in Syracuse, NY. In the manufacturing sector, IBEW members have experience with clean room protocols, keeping environments free of contaminants and the precise, specialized requirements of semiconductor fabrication.

IBEW Boise Local Union 291 values its longstanding relationship with Micron and celebrates Micron's close connection with the Boise community. A partnership with Local Union 291 would be mutually beneficial as it relates to training, recruiting, and retaining a diverse, productive, qualified workforce. In addition, a partnership with Local Union 291 will help Micron satisfy the following Department of Commerce CHIPS Incentive Program criteria: commitment to workforce development and commitment to the community and growth of the industry. I understand the Boise project will create approximately 750 new jobs, which will be a much-needed employment boon to the greater community.
